Imagine a spring afternoon and you and friends gather to socialize, enjoy wonderful sweet and savory bits and bites



Frank Lloyd Wright -State Conference 2023



Frank's parents' names were Anna and William. They married in 1866 and had 3 children, they divorced in 1884. She raised Frank like a prince. Frank

played with special building blocks as a kid and this inspired him to become an architect. At the age of 20 he attended UW-Madison, although he never earned an engineering degree. Also at the young age of 20 he designed a 900 sq. ft. cottage for Seth Peters that was built in Delton.

He designed the Unity Chapel in 1886 located in Spring Green. In 1887 he designed a home with lights and radiant heating. In 1890 he designed the Hillside Home School that included a theatre.

His homes were constructed with the front door hidden and ceilings very low at the entry, giving people a feeling they are welcomed as they entirely entered. He designed 1,000 homes and 500 were actually built.

Frank had a total of 3 wives and a mistress. He insisted that the mistress be buried next to him which really upset his third wife.

In 1889 he married his second wife, who was an artist and social worker. They divorced in 1922. He had 6 kids with her. He designed Usonian homes that have concrete floors, radiant heat, no basement, used all plywood. Buildings had flat roofs and were low cost for the average family, and had carports. No garage, because a garage would accumulate clutter. Even the house had few closets because he didn't want storage spaces for "junk".

A book was written about him entitled "Loving Frank" explaining his life, written by Nancy Huran. His son, Frank Lloyd Wright Jr. also wrote a book about him. That son was the designer of the Lincoln Logs.
